The Dallas Safari Club (DSC) is sponsoring the Fall S.A.F.E.T.Y. Extravaganza for the Outdoor Adventures programs in fifty public schools. Each semester the DSC sponsors an adventure to Greystone Castle. The purpose of the **Shooting Archery Field Excellency Trials for Youth (S.A.F.E.T.Y.) Extravaganza** is to exhibit the safety lessons taught in the classroom in hunter education and then allow the students the opportunity to shoot a variety of firearms under the guidance of qualified instructors. Students will have one-on-one firearm instruction for rifles, shotguns, pistols, muzzle loaders, compound bows, cross bows, and participate in a 'field exercise course.'

The focus of this event is **SAFETY**. Your student will be under strict supervision at all times. In all cases using firearms or bows, there will be one-on-one instructor-student ratio. **One parent must accompany their student on this trip.** Parents must remain with their student at all times.

Research clearly shows that students who are actively engaged with their parents in extracurricular activities perform better both academically and behaviorally in school. The DSC is committed to providing quality family time. We want the parent to spend a full day with their son or daughter.

All students who are in Outdoor Adventure Education course may participate if the student has:

- Completed a hunter education course.
- Have not participated in the S.A.F.E.T.Y. event.

The DSC will provide charter buses to take all participants/parents to this event. **Buses will depart from Cabela's in Fort Worth, Texas at 6:45 AM, return 6:30 PM.**

Due to the limited parking at Greystone Castle, everyone must ride the charter bus, no exceptions.

The DSC pays for the student, while the parent is requested to pay \$35.00 to the **"DSC Youth Fund"**. These funds establish activity accounts for each school to use directly for student activities at their respective schools. Special Notes:

- There will be no refunds should you miss the trip.
- Scholarships are available for single parent and financially disadvantaged families. This is strictly confidential.
- All students that participate will receive a commemorative event T-shirt, and hat. Students must wear these at the event at all times.
- **One parent must accompany their student on this trip.** Parents must remain with their student at all times.
- **Safety is our top priority during the event.** At times an instructor will adjust proper hand placement or body positioning to ensure safety with a fire arm. If a parent is uncomfortable with proper safety instruction, please inform any volunteer instructor prior to the fire arm safety introduction.
- **We respectfully request that you (parents) do not smoke, bring any work (computers, etc) with you and turn cell phones off. Wear comfortable closed-toe shoes. Significant walking will be required on gravel roads and field areas for all students and parents. Parents must stay with their child at all times.**
- **This is a full day event. Tentative Times: 6:15 AM – 6:45 PM.**
- Registration forms that are not legible, wrong phone numbers (no student phone numbers) or not completely filled out will automatically be eliminated from the screening process for youth hunting opportunities.
- Participants that are “no shows” at Greystone will automatically be eliminated from the screening process for youth hunting opportunities.
- The \$35.00 fee for the “DSC Youth Fund” is given back to each school through the activity accounts. Each school will have access to their accounts for activities, equipment and events for their students.
- **Every year some youth hunting opportunities come along. If you would like to have your name placed in the drawing for a hunt, then you need to realize that the instructors, group leaders, and teachers will evaluate you while participating at Greystone Castle.**
